#### **Board of Directors Educator Information**

The Board of Directors is the governing body of Ohio Family, Careers and Community Leaders of America Association. Its adult directors are considered the Associations members for votes as required by Ohio FCCLA Code of Regulations, unless otherwise stated in the Ohio FCCLA Code of Regulations for a vote of the student delegates. The Board receives and acts upon the recommendations of State Staff relative to programs and financial matters. Meetings take place twice per year. See Ohio FCCLA Code of Regulations for the composition of the Board.

#### **ELIGIBLITY**

Candidates must be a local chapter adviser for at least two years, and must currently be serving as a local chapter adviser affiliated with the state organization. In addition, they must be a member of Ohio Association Teachers of Family and Consumer Sciences (OATFACS) and must attend State Leadership Conference.

#### **POSITIONS:**

The following positions are a three-year term and will be available on a rotation basis:

- Family and Consumer Sciences: (3) positions on a rotation schedule;
- Education and Training: (1 position) Can be either from Early Childhood Education or Teaching Professions pathways;
- Hospitality and Tourism: (1 position) Can be either from Culinary Arts or Hospitality pathways.

#### **CRITERIA:**

Family, Career and Community Leaders of America State Staff will screen applications based on the following criteria. Selection of final candidate(s) will be voted on by the Executive Council Board.

- 1. What experiences does the candidate have on any community Board/or community involvement or other leadership opportunities working organized Boards of Directors?
- 2. What experiences does the candidate have in FCCLA State association or state events?
- 3. List professional association memberships and include any offices held in these associations.
- 4. What experiences does the candidate have in regional and state events and programs?
