**Student Conduct:** Students are not permitted to roam the school or go to areas other than where the competition is located.

<u>Competition:</u> Students should find their event room location upon arrival. Competition time changes are not allowed. Students should report to the event room <u>at least 15 minutes prior</u> to their scheduled presentation time.

<u>CDE Entry Cancellation:</u> All event entry cancellations are to be made using the link posted on the Ohio FCCLA Regional Career Development Event Tab by February 20th, 2020.

<u>Event Participant Changes:</u> All participant changes will be made on the day of competition. Forms will be completed by competitors. See CDE Handbook for guidelines
